THE BOARD REVIEWED VARIOUS DOCUMENTS RELATED TO THE GCW SOLAR PROJECT. MR. DAVIDSON AND MR CYR BRIEFED THE BOARD ON CONTRACTUAL DOCUMENTS AND THE KICK OFF MEETING RECENTLY HELD AT GCW. THE BOARD WAS INFORMED THAT THE CONTRACTOR WAS THINKING ABOUT CHANGING THE SOLAR FIELD ANCHORING FROM BALLAST TO DRILLED ANCHORS. THIS CHANGE WILL REQUIRE AN ENVIRONMENTAL REVIEW BY TERC. THE BOARD WAS ALSO INFORMED THAT THE LEAD TIME FOR THE LITHIUM BATTERIES MAY THREATEN THE IN-SERVICE DATE OF THE SOLAR FIELD; HOWEVER, THE PRIMARY CONTRACTOR WAS ABLE TO SOURCE THE NEEDED BATTERIES BY A FIRM THAT HAD THEM IN STOCK.

DUE TO PREVOISLY SCHEDULED MEETING THE HTUA BOARD ON A MOTION BY MR. VAUGHN AND A SECOND BY MR. MONTANA, THE BOARD VOTED TO TABLE THE REST OF THE MEETING UNTIL A LATER DATE.
