### 7. HTUA VACANCIES

a) BOARD MEMBER SEARCH

MR. DAVIDSON INFORMED THE BOARD THAT NO BOARD MEMBER APPLICATIONS HAVE BEEN RECEIVED TO DATE

- b) HTUA JOB DESCRIPTIONS
  - 1. GENERAL MANAGER
  - 2. ASSISTANT GENERAL MANAGER
  - 3. MANAGER OF GENERATION
  - 4. HTUA ELECTRICAL ENGINEER

THE BOARD REVIEWED THE DRAFT JOB DESCRIPTIONS FOR KEY POSITIONS AT HTUA. MR. CYR INDICATED THAT NOT ALL FOUR POSITIONS NEED TO BE FILLED AT THIS TIME. ONLY ONE POSITION NEEDS TO BE FILLED AT THIS TIME—GENERATION MANAGER, HOWEVER, THE OTHER POSITIONS HAVE SIMILAR QUALIFICATIONS AND DUTIES THUS THE SELECTED CANDIDATE COULD HAVE ANY ONE OF THE TITLES LISTED AS LONG AS THAT INDIVIDUAL HAS THE CAPABILITY TO PERFORM GENERATION MANAGER FUNCTIONS. THE PLAN WOULD BE, ONCE POSITIONS ARE APPROVED BY COUNCIL, IS TO POST THE OPENINGS AND SEE IF ANY RESPONSES ARE RECEIVED. THE ACTUAL POSITION THAT IS FILLED—IS DEPENDENT UPON THE QUALIFICATIONS OF THAT SPECIFIC APPLICANT.

### 8. GCW SOLAR -PROJECT UPDATE

a) GENERAL UPDATE - BI-WEEKLY MEETING—SEQUENCE OF OPERATIONS- PURCHASE OF SPARE MODULES

THE BOARD REVIEWED THE HANDOUTS IN THE BOARD PACKAGE. ADDITIONALLY MR. DAVIDSON AND MR. CYR UPDATED THE BOARD ON THE STATUS OF THE PROJECT. THE PROJECT IS SCHEDULED FOR AN IN SERVICE DATE OF MID-APRIL. THE BOARD WAS UPDATED ON SAFETY TRAINING FOR RESPONDING TO BATTERY FIRES, SEQUENCE OF OPERATIONS AND A COPY OF THE PURCHASE ORDER FOR SPARE MODULES AT \$9,000 APPROXIMATELY \$3,000 LESS THAN THE AMOUNT APPROVED BY THE BOARD ART THE LAST MEETING.

### 9. GCW POWERLINE

a) POWER LINE ENGINEERING RFP UPDATE

THE SUCCESSFUL BIDDER HAS AGREED TO HOLD THEIR QUOTE PRICING FOR SEVERAL MORE MONTHS AS HTUA OBTAINS FINAL DIRECTION FROM COUNCIL. THE REQUIRED DIRECTION FROM COUNCIL PERTAINS TO THE RECENTLY ANNOUNCED COLORADO RIVER DIVERSION PROJECT. THE LOCATION OF THE ACTUAL DIVERSION- DIAMOND CREEK OR GCW MAY IMPACT THE POWER REQUIREMENTS OF THE PROPOSED LINE. ADDITIONALLY, ANY MONIES SPENT IN SUPPORT OF THE WATER DIVERSION PROJECT MUST BE ACCOUNTED FOR PROPERLY TO ENSURE EVENTUAL TRIBAL RE-IMBURSEMENT.

### b) UNES IMPACT STUDY UPDATE

TEP HAS COMPLETED A DRAFT OF THE SYSTEM IMPACT STUDY. A COPY OF THE DRAFT WAS INCLUDED IN THE BOARD PACKET. MR. DAVIDSON AND MR. CYR WENT OVER THE DRAFT STUDY WITH TEP ENGINEERS ON WEDNESDAY, FEBRUARY 22, 2023. SOME MINOR CORRECTIONS WERE IDENTIFIED WHICH TEP WILL ADDRESS—THE FINAL STUDY SHOULD BE READY IN TIME FOR THE NEXT BOARD MEETING.

c) DOE GRANT APPLICATION - EXTEND GCW MICRO GRID

THE BOARD REVIEWED SUPPORTING DOCUMENTS FOR THE GRANT APPLICATION TO FUND THE EXTENSION OF THE GCW MICRO-GRID.

d) GCW EMERGENCY RESPONSE CONTRACT - DRAFT

THE BOARD REVIEWED A DRAFT OF THE KEY TERMS FOR A CONTRACT WITH A THIRD PARTY PROVIDER THAT CAN RESPOND TO EMERGENCIES AND OUTAGES RELATED TO THE MICRO GRID. THE CONTRACT HAS BEEN SENT TO THE TRIBE'S INSURANCE COMPANY FOR NOW AND THEN WILL BE FORWARDED TO THE TRIBE'S LEGAL COUNSEL FOR ADDITIONAL EDITS AND FINAL REVIEW.

e) HUALAPAI MASER PLAN COMMITTEE

MR. DAVIDSON BRIEFED THE BOARD ON THE COUNCIL DIRECTION FOR THE PLANNING DEPARTMENT'S TO CREATE COMMITTEE TO DEVELOP/UPDATE A MASTER PLAN FOR THE HUALAPAI TRIBE. TO DATE, THERE HAS BEEN GREAT COMMUNITY RESPONSE TO SERVE ON THE COMMITTEE INCLUDING BOARD MEMBER JASON DAVIS.
