## THEBOARD WAS UPDATED ON THE PROJECT STATUS

- SOLAR PANELS AND MOUNTING STRUCTURES BY END OF THIS YEAR
- BALANCE OF PROJECT BY END OF 2<sup>ND</sup> QUARTER 2023
- MICRO GRID CONNECTION –BY END OF FIRST QUARTER 2022
- IMMEDIATE NEED TO UPGRADE THE CONTROLS FOR THE EXISTING GENERATORS MUST BE UPGRADED TO INTERFACE WITH THE SOLAR SYSTEM

AFTER REVIEWING THE PROJECT'S BUDGET, AND FINDING THAT SUFFICIENT FUNDS REMAINED FOR THE PURCHASE OF THE NEW CONTROLS FOR THE EXISTING GENERATORS, A MOTION BY MR. MONTANNA AND A SECOND BY MR. DAVIS, THE BOARD APPROVED THE EXPENDITURE OF \$105,000 FOR THE PURCHASE AND INSTALLATION OF NEW GENERATOR CONTROLS ON 3, 750 KW GENERATORS. VOTE (3-0-0)
